Winn Lusk – Winn has not received the results from his scans yet. He is having more episodes of unsteadiness and must often steady himself against the wall when he walks. His pain is worse also. He has been referred to a pain specialist for shots in his neck-spine. Please pray for healing for Winn for all these symptoms.
